Americans with Disabilities Act Compliance

This one-hour program examines the requirement imposed by the ADA for accommodating those with disabilities.

OSHA General Duty Clause - Be Afraid, Very Afraid

This 1- hour presentation presents information about and discusses OSHA's General Duty Clause that states: "Each employer shall furnish to each of his employees employment and a place of employment which are free from recognized hazards that are causing or are likely to cause death or serious physical harm to his employees." During the class, we will discuss areas for which OSHA does not have specific standards and uses the General Duty Clause to issue citations as well as areas for which OSHA has specific standards, yet still uses the General Duty Clause to issue citations even when businesses follow the standards.
